Please note that regardless of how this certificate is completed, the Owner is always ultimately responsible for the payment of water delivered to property owned.

By signing the Certificate of Ownership and Authorization of Agent or Tenant, the signatory expressly acknowledges that all water delivered will be untreated and is to be used solely for irrigation or other agricultural purposes. HUMAN CONSUMPTION IS ABSOLUTELY PROHIBITED. The signatory also expressly acknowledges that the right to order and receive water is subject at all times to IID's Rules and Regulations Governing the Distribution and Use of Water, including any Equitable Distribution Program, as such rules and regulations currently exist or may be modified, amended or revised in the future by the IID.
