



IMPERIAL IRRIGATION DISTRICT RESOLUTION NO. 2-2022

Requesting to Consolidate the General District Election of the Imperial Irrigation District with the Statewide Direct Primary Election to be held on June 7, 2022

WHEREAS, pursuant to California Elections Code sections 1000, 1001 and 1201, June 7, 2022 is a statewide election date and the statewide direct primary date; and

WHEREAS, pursuant to the Uniform District Election Law, specifically California Elections Code section 10503, the Irrigation District Law shall govern first as the principal act, and when the Irrigation District Law contains no provisions on the election matter, the Uniform District Election Law shall govern, and when the Uniform District Election Law contains no provisions on the election matter, the general election laws under the California Elections Code shall govern; and

WHEREAS, pursuant to California Water Code section 22841, the Imperial Irrigation District may designate the general district election to be held on the day provided for the statewide primary election and consolidated with the statewide primary election; and

WHEREAS, pursuant to California Elections Code section 10507, the term of office of each elected IID director office is four years; and

WHEREAS, the term for three elected IID director offices for Divisions 1, 3 and 5 will expire in 2022; and

WHEREAS, pursuant to California Elections Code section 10517, the Imperial County elections official shall conduct the general district election for IID; and

WHEREAS, pursuant to California Water Code section 22841 and Elections Code sections, 10400 and 10401, the Imperial County Board of Supervisors may order the consolidation of the general district election for IID with the statewide direct primary election; and

WHEREAS, IID desires to have its general district election for Divisions 1, 3 and 5 held on June 7, 2022, conducted by the Imperial County and consolidated with the statewide direct primary election held on that same date.

NOW, THEREFORE, BE IT RESOLVED, as follows:

1. The Imperial Irrigation District director offices for Divisions 1, 3 and 5 will expire in 2022 and the IID Board of Directors hereby calls for the general district election to be held on June 7, 2022 to fill these offices. These offices will be elected by division. Candidates will pay for the publication of a statement of qualifications pursuant to California Elections Code sections 10509 and 13307.
2. Pursuant to California Elections Code Sections 10401 and 10403, the IID Board of Directors hereby requests that the Imperial County Board of Supervisors order the consolidation of the IID general district election with the statewide direct primary election held on June 7, 2022, for the purpose of electing the three director offices for Divisions 1, 3 and 5.
3. The IID Board of Directors hereby acknowledges that the consolidated election will be held and conducted in the manner prescribed in California Elections Code section 10418.
4. Pursuant to California Elections Code sections 10509 and 10522, the IID Board of Directors hereby direct the secretary of the board to immediately deliver this resolution to the Imperial County Registrar of Voters by personal delivery and/or certified mail as notice of the calling of the general district election and the request for consolidation of the election. The Imperial County Registrar of Voters has received all official maps of the district boundaries and the boundaries of Divisions 1, 3 and 5.
