

**IMPERIAL IRRIGATION DISTRICT  
RESOLUTION NO. 62-2022**

**DECLARING ELECTED CANDIDATES RECEIVING  
THE MAJORITY OF THE VOTES CAST**

**WHEREAS**, the Imperial Irrigation District (“IID”) is an irrigation district established under the Irrigation District Law, California Water Code section 20500, *et seq.*; and

**WHEREAS**, on June 7, 2022, the Imperial County Registrar of Voters conducted the general district election for the Imperial Irrigation District for Directors of Divisions 1, 3, and 5, as consolidated with the statewide primary election; and

**WHEREAS**, the elections for Directors of Divisions 1 and 5 had two candidates, with one candidate in each division receiving a majority of votes cast determining them as successful candidates for those divisions; and

**WHEREAS**, Mr. Alex Cardenas was the successful candidate for Division 1, as indicated in the Imperial County Registrar of Voters’ Certificate of Election, attached hereto as Exhibit A; and

**WHEREAS**, Ms. Karin Eugenio was the successful candidate for Division 5, as indicated in the Imperial County Registrar of Voters’ Certificate of Election, attached hereto as Exhibit B; and

**WHEREAS**, with respect to Division 3, there were four candidates in the general district election with no single candidate receiving a majority of the votes cast and pursuant to California Water Code section 22970, a runoff election was held; and

**WHEREAS**, the runoff election for Division 3 was held on November 8, 2022, conducted by the Imperial County Registrar of Voters conducted, and consolidated with the statewide general election; and

**WHEREAS**, Ms. Gina Young Dockstader received a majority of votes cast, making her the successful candidate in Division 3 as indicated in the Imperial County Registrar of Voters’ Certificate of Election, attached hereto as Exhibit C; and

**WHEREAS**, California Water Code section 22970.30 requires the Board of Directors to declare the candidate elected receiving the majority of the votes cast for that office in a runoff election.


**NOW, THEREFORE, BE IT HEREBY RESOLVED** that:


- 1) The IID Board of Directors finds that the above recitals are true and correct.
