



# Part 1: Terms and Conditions

Please read the Terms and Conditions carefully and sign below.

1. I understand that funding is contingent on proposal review and scoring as awarded by the evaluation committee. Funds are limited and grants are not guaranteed. This program may be modified or terminated without prior notice.
2. I understand that all projects must be completed by **Monday, November 30, 2026**.
3. I understand that the trees must be planted at the provided address listed on this application.
4. I understand it is mandatory to comply with IID’s Vegetation Management Program: <https://www.iid.com/power/vegetation-management>
5. I understand that a final report/summary, copies of receipts, invoices and other supporting documentation must be submitted no later than **Monday, November 30, 2026**.
6. I will allow, if requested, an IID representative reasonable access to my premise to verify tree planting project completion before the final grant payment is issued. I understand that a grant will not be paid or I will be invoiced for the full grant amount awarded, if I refuse a verification inspection.
7. I agree that the selection, purchase, planting, ownership and maintenance of the trees listed in this application are my sole responsibility and that my supplier, landscaper or contractor who provided these products or improvements is not an agent or representative of IID. I also understand that, with respect to the trees I choose to plant, IID makes no warranty, whether expressed or implied, including warranty of merchantability or fitness for any particular purpose. I agree that IID has no liability whatsoever concerning (1) the trees I choose to plant; and (2) the workmanship of any third parties. I agree that in no event shall IID be liable for property loss or damage resulting from its activities under this application.
8. I agree to care for and maintain the incentivized trees for a minimum of three (3) years or the typical lifespan of a tree. If I do not comply with this requirement, I agree that IID has the right to seek a refund for a prorated amount of the original incentive initially paid to me, based on the period of time that I provided the related tree care and maintenance.
9. I understand that the grant amount will be determined by an IID evaluating committee during the application review process.
10. If a tenant, I understand I am responsible for obtaining the property owner’s permission to plant the trees for which I am applying for a grant. My signature on this application indicates I have obtained this permission.
11. TAX LIABILITY—Grants are taxable. You are urged to consult your tax advisor concerning the taxability of grants. IID is not responsible for any taxes that may be imposed on you as a result of your receipt of this grant.
12. I certify that I will comply with all program requirements and with all applicable local, state or federal laws and Underground Service Alert (DigAlert®). I understand it is my responsibility to ensure the contractor holds the appropriate license for the work performed.
